Brief Project Description:

The proposed project is a Riverside Small-Scale liquified natural gas (LNG) plant on an acquired land of 8 hectares (80,000Sqms) at Ogbele, Ahoada Fast L.G.A, Rivers State. The project involves a feed-gas supply of about 35mmcf/d and installation of a 2x350TPD LNG plant, contributing to the reduction of gas flaring and enabling the supply of natural gas to support industrial and commercial developments. With production capacity of about 700TPD.

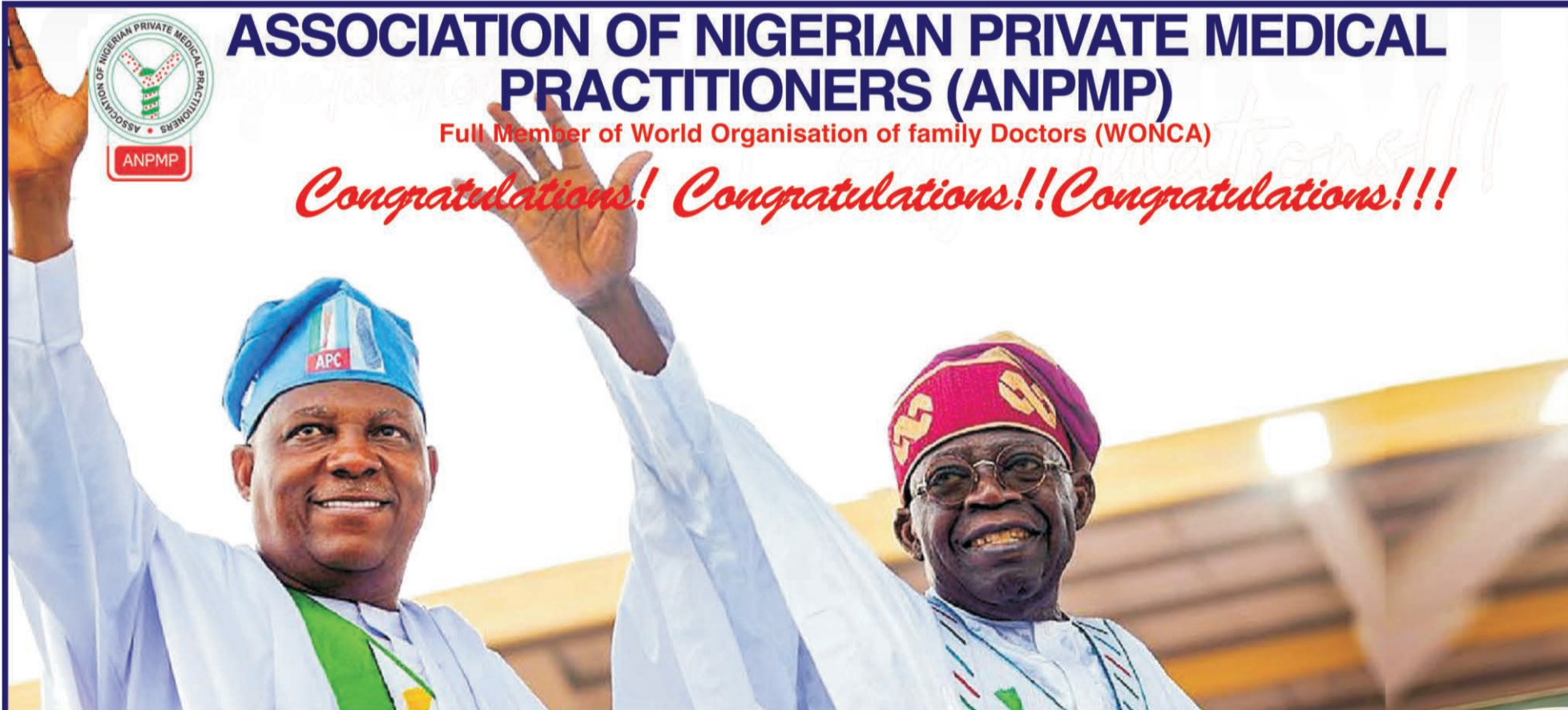
